The County Forester work directly with landowners to provide information specific to a single property or general to regional forestry resources. The County Forester also manages the Use Value Appraisal (Current Use) program, which allows landowners who practice long-term forest management to have their land appraised for property taxes based on its value for forestry rather than fair market value (which generally lowers taxes).
